## Buckinghamshire Council annual parking report 2020 to 2021

#### 1. Introduction

This report is produced in accordance with section 55 of the Road Traffic Act 1984, as amended by the Traffic Management Act 2004 (TMA), and also meets with the requirements of the Local Government Act 2015.

### 2. Background

Buckinghamshire Council is responsible for on and off street parking across Buckinghamshire.

The parking provision under the remit of Parking Services equates to 10,998 parking spaces off street, including 436 disabled bays and 63 electric vehicle recharging bays. The parking provision on street is approx. 7,400 parking spaces with an additional 20 electric vehicle charging points. The parking provision is located:

Enforcement of the three country parks car parks, comprising 901 car parking spaces, is enforced alongside the above provision. Parking enforcement is carried out in accordance with the Traffic Management Act 2004

For on street, enforcement of parking restrictions includes, school keep clears, bus stops, single and double yellow lines, loading restrictions, reserved bays, limited waiting, and zebra crossings (this is not an exhaustive list).

### 3. Penalty charge notices

The statutory order sets out the value of a Penalty Charge Notice, this is in two elements depending on the seriousness of the contravention. The more serious contraventions are charged at the higher level of £70.00 (£35.00 if paid within 14 days of issue); the less serious contraventions are charged at the lower level of £50.00 (£25.00 if paid within 14 days of issue). The table below sets out the number of Penalty Charge Notices issued throughout 2020/21, broken down into higher/lower level Penalty Charge Notices, payment information, and appeals.
