Introduction

This Annual report provides an overview and insight into Parking Services and parking enforcement within the borough of Bury. It also documents financial information relating to parking income and expenditure and Penalty Charge Notices (PCN's).

In October 2002 the Council adopted powers to carry out decriminalised parking enforcement. At the time the Council appointed a contractor, NCP Ltd, to undertake the administration and processing of PCN's and the provision of civil enforcement officers to undertake the enforcement. This contract ended on 31 March 2008 and a new 5 year contract commenced on 01 April 2008.

Since this time we have entered into two further contracts. The current appointed contractor is NSL.



Background

Parking Services are a team of five people who manage parking throughout the borough. Their day-to-day responsibilities include dealing with parking appeals; administration of parking and resident only permits; issuing waivers and organising suspensions; collating pay and display data; liaising with the enforcement contractor (NSL); and dealing with queries from members of the public, Councillors and other internal services.

Chapter 3

Parking enforcement

Civil enforcement officers (CEO's) are employed to carry out parking enforcement across the borough. The CEO's are employed by NSL who are the appointed contractor working on behalf of the Council.

One of the main roles of a CEO is to assist drivers and provide help and advice wherever possible. If a vehicle is parked in contravention and the driver or a passenger is present the CEO will advise them that they need to move the vehicle and will be able to provide advice on alternative places to park that aren't in contravention.

The majority of drivers do park responsibly, however, a small minority continue to park inappropriately and in contravention. By parking inappropriately drivers cause congestion, safety and visibility issues for other road users.

CEO's are responsible for enforcing all public car parks, a majority of on-street parking restrictions, residents parking zones, school keep clear markings, dropped crossings and bus lanes across the borough. They do not have the necessary powers to enforce any moving offences including cycle lanes, speed limits, red lights or yellow junction boxes. These offences still remain under the jurisdiction of Greater Manchester Police (GMP) as so some 'white-line' highway restrictions.

A lot of confusion lies around the ability to issue PCN's to vehicles parked on footways. All enforceable parking restrictions have a traffic regulation order (TRO) associated to them. Our ability to enforce on footways is dependent on what is listed within the individual TRO. If there is a parking restriction in front of the footway and the TRO covers the area to the building line or back of footway then a PCN can be issued. In other cases where we are unable to enforce, GMP still possess the necessary powers to do so.

It is a common myth that CEOs hide behind corners waiting to pounce on unsuspecting drivers and issue tickets as quickly as possible. This is not the case and the uniform that CEO's wear is highly visible and makes them stand out.

^{*}Other reasons for cancelling a PCN could include but are not limited to representation being allowed, additional evidence being supplied, inadequate lining or signing to uphold the PCN, mitigating circumstances, adjudications allowed by the independent adjudicator, production of a disabled badge or valid permit.

Parking initiatives

During 2015 the Council worked in Partnership with NSL to introduce a number of initiatives to assist in more efficient enforcement and provide a safer working environment for civil enforcement officers.

With the award of the new contract we have introduced body camera technology - for CEO safety in designated areas and to support PCN issue and reduce appeals. These have led to the successful prosecution of several assailants and assisted the Police with evidence for non-parking incidents.

All NSL vehicles are now equipped with Masternaut vehicle tracking software – this provides the following benefits.

- Driver safety through GPS tracking
- · Fuel usage data for budget management
- Emissions data for compliance with environmental objectives
- Driver performance data for compliance with NSL's company standards

In January 2016 we introduced online case management – providing accessibility for the public whilst reducing back office administration and appeals. In the technological advanced world we live in today the improvement and continual advancement of online services is critical. This means that appellants can now manage their PCN's online at any time of the day or night. They also have the facility to view photographs of the contravention.

NSL's new digital radio system has improved the range/quality of communication links with CEOs and tracking via radio units.

New TC55 Handheld Computers are currently being trialled. These are fitted with SOTI for managing battery life and faults in real time and an integrated camera for instant association with PCN when downloaded. The system is android based so it gives us the facility to add additional applications retrospectively such as Environmental Enforcement and street furniture fault reporting, even giving access to useful web pages. One example is the access to Transport for Greater Manchester (TfGM) website. This means that CEO's can advise members of the public on bus and Tram information.

^{**}The income we receive from parking is used to meet the costs of operating the car parking service, including maintenance, rates, lighting and parking enforcement. Any net income contributes to other transportation costs and maintenance of highways in the Borough. This is in accordance with the Traffic Management Act 2004, which allows the excess to be used for further traffic and parking schemes, public transport services, highway or road improvement projects or for environmental improvement in the Local Authority's area.

Bus lane enforcement

Bury Council is dedicated to supporting the use of alternative forms of transport and over the years has implemented a number of schemes to assist in the promotion of public transport.

Improvements to public transport service and reliability assists with the free flow of traffic through the Borough. The success of buses as a major form of transport to combat the car depends on the speed and reliability of the service. To help bus companies achieve a reliable and speedy service, bus lanes have been introduced at various locations across the borough. These lanes allow the bus to avoid the congestion and reach the front of the queue, giving the bus priority.

There are currently eight bus lanes in Bury at the following locations.

- Rochdale Road, Bury operating Monday to Friday, 7am to 10am and 4pm to 7pm
- **Bolton Road, Bury** (3 sections) operating Monday to Friday, 7am to 10am and 4pm to 7pm
- Manchester Road, Bury operating Monday to Saturday, 7am to 7pm
- Bury Old Road, Prestwich (2 sections) operating Monday to Friday 7am to 10am and 4pm to 7pm
- Bury New Road, Whitefield operating Monday to Friday, 7am to 10am and 4pm to 7pm



Since the introduction of bus lanes in 2006 the level of abuse of vehicles travelling in bus lanes has increased and in October 2011 Bury Council introduced bus lane enforcement.

Bus lane enforcement is carried out using a CCTV camera car. Before any device can be used for Civil Parking, Moving Traffic or Bus Lane contraventions, it must be certified by the Secretary of State as an 'Approved Device'. This simply means that the technical construction and intended use of the system has been thoroughly inspected and approved as being 'fit for purpose' to carry out the type of enforcement specified. Our CCTV vehicle has received the necessary approved device status.

An essential and integral part of any CCTV system is a code of Practice to ensure that issues such as privacy and integrity are properly respected. Bury Council follows the Code of Practice for Bus Lane Enforcement using attended CCTV equipment for Approved English local Authorities outside of London.

⁺The income we receive from parking is used to meet the costs of operating the car parking service, including maintenance, rates, lighting and parking enforcement. Any net income contributes to other transportation costs and maintenance of highways in the Borough. Blue badges

Over the years Bury Council has carried out joint working with Greater Manchester Police to try and combat fraudulent uses of blue badges.

The Council's Corporate Fraud Team became active in early 2016 and took on the role of investigating blue badge misuse.

Blue Badge enforcement days were set up and time has been spent in high usage areas. As a result of this work they issued 3 warning letters, referred one allegation to the issuing authority and referred one case to the Police.

More involved investigations have taken place since this time and these will be reported in more detail in next year's report.

Residents' parking zones


A residents' parking zone is a Controlled Zone that restricts parking to those displaying a permit. Residents' parking zones or pass this point zones are introduced in areas where residents are prevented from parking within a reasonable distance from their property due to non-residents taking up the road space.

The Council has a set criteria for assessing residents' parking requests. The criteria considers if residents have an alternative form of parking, how often the problem occurs and how frequently. In order for an area to meet criteria non-residents' vehicles must be parked in the area for 4 + hours a day on a regular basis.

In some residents' parking zones dual parking bays exist. In these bays residents can park for an unlimited amount of time (whilst displaying a valid Permit) and all other users can park for a time limited period.

Residents' parking zones can be implemented in two ways either as a residents parking zone or as a pass this point zone. In both types of zones permitted vehicles must display a valid permit however, in a pass this point zone, the need for repeater signs and bay markings within the zone is not required. Controlled zone signs are present at the entry points of all residents parking zones and pass this point zones. In a residents parking zone each street will be lined and signed in accordance with legislation. In a pass this point zone only entry and exit points to the zone will be signed and no bay markings are required. In both zones only permitted vehicles are allowed to park and valid permits must be displayed.

There are currently 12 active residents' parking zones across the borough.

All permit fees contribute towards the cost of setting up new schemes, enforcement and administration. There is no income surplus or deficit.


Prestwich Parking Strategy

In 2014 a parking summit was held with Prestwich Councillors to discuss a number of longstanding parking problems. A decision was made that the most effective way to tackle the reoccurring problems was through the creation of a Parking Strategy.

A task group was set up comprising officers from various departments and Prestwich Councillors. Consultations were carried out in the form of an online survey and officers attended a public forum to promote the survey and to engage with members of the general public and local businesses.

In 2015, using the feedback and comments received during the consultations, a Parking Strategy for Prestwich was formally approved and an action framework was produced. A copy of the framework is attached as Appendix A to this report and it outlines the future aims and objectives for parking in Prestwich.

One of the focus areas highlighted in the action framework is looking at control mechanisms around how long and where people park. In response to this Clifton Road car park was converted to a 2-hour short stay car park. Previously business workers were parking up on the car park all day. This left no availability for visitors or shoppers to the nearby businesses. Since the car park has changed there has been positive feedback from both visitors and businesses.

Prestwich Parking Strategy Action Framework

This report forms a supporting document that should be read in conjunction with the Prestwich Parking Strategy. It outlines an action framework that aims to address the concerns raised during the consultation stage. The outcomes within this framework are linked to the vision and objectives contained within the main strategy report.

The agreed main areas of focus are: -

- 1. The provision of parking
- 2. Protecting residential street from non residents
- 3. Looking at control mechanisms around how long and where people park.
- 4. Improving information relating to where people can park within Prestwich.

How will we achieve outcomes?

- 1. Work with prospective partners with regard to parking which allows for mutually beneficial outcomes.
- 2. Ensure parking is included as part of any proposed regeneration plans for Prestwich.
- 3. Cater for short stay visits to support daytime and evening commercial activity. In particular maximise the availability of short stay spaces in prime, central locations for use by shoppers and other short stay users. Short stay parking generates a high turnover of spaces allowing more visitors to be accommodated per space. Availability of short stay spaces is essential to maintaining the commercial viability of the town centre.
- 4. Review TRO's in problem area's to ensure the most suitable restrictions are in place.
- 5. Support the introduction of residents parking zones in accordance with the agreed policy, where deemed necessary and supported by the community.
- 6. Fundamental to any parking strategy is the need for efficient and appropriate parking enforcement. Civil Parking Enforcement (CPE) already operates across the borough under the remit of achieving

- compliance of existing parking restrictions. This operation will continue to be reviewed and monitored to ensure cost-efficient delivery.
- 7. Unenforceable lines and signs will be reinstated (as identified) to ensure appropriate enforcement can be carried out.
- 8. Review directional signing and the information available relating to where people can park within Prestwich.
