## BLAS/ 07/11 Urgent Decisions

## BLAS/07/13 Final Revenue and Capital Accounts, 2006/2007

#### BLAS/07/14 New BLASJC Member Councils

A report of the Lead Officer was submitted requesting the Joint Committee to agree to extend the Chief Bus Lane Adjudicator's appointment to cover the area of a number of Councils who have become party to the BLASJC Agreement.

- 2. To confirm the appointment of the Chief Bus Lane Adjudicator and other part time Bus Lane Adjudicators (co-terminous to their current appointments) to cover the areas of the authorities referred to in (1) above, with effect from their commencement dates appropriate to each authority area.

## **BLAS/07/15** General Progress and Service Standards

A report of the Lead Officer was submitted on progress in relation to (a) the take up of civil enforcement of bus lane powers by Councils in England (outside London), and (b) service standard performance during 2006/2007.

#### Decision

  - b) 90% of cases to be offered a personal hearing date within 12 weeks of receipt of the Notice of Appeal.
- 4. To approve the revised service standard for postal decisions:

80% of postal decisions to be made within 7 weeks of receipt of the Notice of Appeal
